What is Martyn's Law?

Martyn's Law, also known as the Protect Duty, is a vital legislative measure introduced by the Home Office, aimed at strengthening the security of public spaces and events in the face of rising terrorism threats.


This law has been established following the tragic 2017 Manchester Arena bombing, where Martyn Hett was one of 22 victims. The new regulations aim to safeguard staff and visitors at venues, ensuring that businesses are prepared to handle potential security breaches.



Martyn Hett, one of the victims, became the symbol of a wider call for action to ensure venues take steps to better protect the public. His mother, Figen Murray, campaigned tirelessly to bring about this change, highlighting the lack of security measures at publicly accessible locations.

The law is a tribute to the lives lost and a proactive step towards preventing similar tragedies in the future.

The law mandates that premises with a maximum capacity of over 100 people must implement appropriate protective measures, while those hosting more than 800 people must adhere to additional security requirements. Martyn's Law was recently given Royal Assent, and businesses are now required to comply, with an implementation period of up to 24 months.

The regulations introduced by Martyn's Law are tiered based on the size and capacity of the venue. They provide clear guidelines for both small-to-medium-sized enterprises and large organisations. For venues with a capacity of over 100, the following measures are required:

Training: Staff must be trained to recognise security vulnerabilities and suspicious activities, ensuring they can respond quickly and effectively.

Information Sharing: Premises must collaborate with local authorities, emergency services, and other relevant parties to identify and address potential security threats and ensure comprehensive public safety.



Preparedness Plan: A documented plan outlining the security measures and responses to potential threats must be in place. This ensures a swift and coordinated response in the event of an incident.

For venues with a capacity exceeding 800, further security measures are required, including:

Risk assessments to identify vulnerabilities and ensure preparedness

Enhanced training for staff to build a culture of vigilance and improve security awareness.

The installation of physical security systems, such as CCTV, access control readers, and security monitoring systems, which are all critical elements under the new regulations.


